French Language Bursary Program for Nova Scotia Teachers

OBJECTIVE

To encourage teachers who hold a Nova Scotia teacher's certificate to pursue courses which are either pedagogical in nature or designed to improve French language competencies.

BURSARY VALUE

UP TO \$300 PER WEEK if you will live on campus for the duration of the course, limited to receipted expenses for tuition, lodging, and meals.

UP TO \$750 PER COURSE if you will live off campus, limited to the tuition paid for the approved 3 credit course.

LIMIT OF \$1500 PER TEACHER per school year (September 1 to August 31).

APPLICANT ELIGIBILITY CRITERIA

You must

- · live in Nova Scotia
- be a Canadian citizen or permanent resident
- · have a valid Nova Scotia teacher's certificate
- be employed by or actively seeking employment with a Nova Scotian Regional Centre for Education or the Conseil scolaire acadien provincial (CSAP)

COURSE ELIGIBILITY CRITERIA

Courses for which the bursary is granted must be

- taken at Université Sainte-Anne;
- · or at the Master's level in French at a Canadian post-secondary institution
- · either pedagogical in nature or immersion courses designed to improve French fluency
- · at least two weeks in duration



APPLICATION DEADLINES

October 15 for fall or winter courses

April 30 for spring or summer courses

Submitting by register mail (recommended): postmarked on or before the due date

REQUIRED DOCUMENTS

- A completed application form incomplete applications are not processed
- Photocopies or electronic copies (e.g., pdf, jpeg) of the following:
 - · valid Nova Scotia teacher's certificate
 - proof of Canadian citizenship or permanent residence — birth certificate, passport, citizenship card, or permanent residency card
 - proof of social insurance number SIN card, pay stub or other official documentation displaying SIN
 - · course description
- If you select "preparing to teach" as your teaching status, please include official transcripts of university-level French courses completed to date

Note: The Nova Scotia Teachers Union (NSTU) card will not be accepted in lieu of the Nova Scotia teachers certificate.

SELECTION PROCESS

Program staff consult with French language consultants/coordinators in the applicable Regional Centre for Education or the Conseil scolaire acadien provincial (CSAP) in the awarding of bursaries. Not all eligible applicants receive a bursary.

You will be notified (by mail), within 6 weeks after the application deadline, whether you have been offered a bursary.

SUBMIT PROOF OF COMPLETION WITHIN 6 WEEKS

To claim the bursary, you must submit the following documents within 6 weeks of completing the course:

- your official transcript with the university's seal, submitted in an envelope sealed by the institution OR submitted electronically from the Registrar's email address
- the original copy of the appropriate receipts or a scanned version if submitting by email

Note: Late submissions may not be reimbursed.

CONDITIONS OF REIMBURSEMENT

- You must immediately report any changes to the approved courses to the French Program Partnerships Division at the Department of Education and Early Childhood Development to ensure continued eligibility for the bursary. Failure to do so may result in the loss of the bursary.
- You must successfully complete approved courses to receive reimbursement.
