Thank you for your patience as we work to enhance child care in Nova Scotia. We are committed to working with you as we implement the federal-provincial child care agreement. We appreciate your feedback and we look forward to more engagement in the coming days and months. An update on the Engagement Table will be coming soon, and we will share information when it is available.

Over the past few months, we have been listening to your comments, and we are acting on your feedback. Based on your feedback and requests, we are making operational changes and clarifications to help you succeed.

### Adapting spaces to meet demand

Last fall, a hold was placed on requests to expand or reallocate spaces for private operators. This was done to reflect Nova Scotia's commitment under the Canada-Wide Agreement and provide time for system planning. I am pleased to share that operators will again be able to submit a change request to the department to request a licensing change to reallocate spaces within your centre. Starting today, all licensees will have the flexibility to **redistribute** existing spaces through the change request process to meet community demand. This change will give licensees more flexibility and benefit families seeking care.

We encourage you to reach out to your Early Childhood Development Consultant or Licensing Office to discuss your planning and future goals.

Please note this change is for reallocation of spaces and not space expansion. More information will be shared with the sector in the coming weeks and months about expansion based on the Fall Expression of Interest, and this topic will be explored more fully with The Early Learning and Child Care Engagement Table.

## **Update on business sales**

We have received questions regarding business sales and would like to share that buyers of private child care businesses (e.g. sole proprietor, partnership, corporation, limited company) are eligible to apply for a new licence to acquire a currently licensed child care centre if they wish to do so.

A licence may be provided to the new owner with the same total licence capacity as the acquired centre, provided the new owner meets all requirements under the Act and Regulations and supports the same community of families. # Pilot project for not-for-profit transition - NEW

We've heard from some private operators that they are interested in transitioning to a not-for-profit model. To support these operators, we've developed a new pilot project where private operators can choose to dissolve and resume under an existing not-for-profit or new not-for-profit board of directors.

The results of the pilot will be used to provide information on what's involved and the best way to move forward. Transition to a not-for-profit model is <u>not</u> required to access reduced parent fees, improved compensation for ECEs, or future funding agreements.
