The Individual Program Plan (IPP) <i>criteria</i> page contained too many check boxes regarding the IPP development process.	We removed the <i>criteria</i> page from the IPP.	Reduces clicks, streamlines forms	Complete
TIENET users must manually set each document to <i>final</i> . This increases workload.	We applied <i>bulk finalization</i> to the School Meeting Minutes, IPP Report, and Consent & Information Sharing forms.
